The three-year lock-in period enables participation in long-term growth potential of the equity market.

The scheme follows the broad investment philosophy of Business- Management-Valuation (BMV) framework which aims to scout for companies with superior and sustainable earnings growth potential at reasonable valuations.

- Cash position stands at 4.6% (vs 4% last month).




HISTORIC MARKET CAP (% of Net Assets)






